

INTERNAL REGULATIONS OF THE ICE RINK

1. The opening and closing times of the ice rink, as well as the applicable rates, are posted at the entrance and at the ticket counter of the Stade Nautique Rainier III, and are also available on the official website of the Monaco Town Hall. These must be strictly observed.
2. Ticket sales and access to the ice rink end 30 minutes before the facility closes to the public.
3. Access to the ice rink is subject to a fee, based on the rates set by a resolution of the Municipal Council.
4. Students attending schools in Monaco and students residing in Monaco — upon presentation of valid documentation (student ID or school correspondence book) — or whose parents work in the Monegasque administration (upon presentation of a Cercle A card), are eligible for a discounted seasonal school pass. An adult seasonal pass is also available at a reduced rate for Monegasque citizens and residents of the Principality, upon presentation of valid proof (residency card or Monegasque ID card).
5. During visits by Monaco schools, the ice rink will be divided into two zones, with no change in the ticket price.
6. All ticket sales are final and non-refundable.
7. Upon request, a helmet and a protective kit (elbow pads, knee pads, and wrist guards) are available. An ID card will be required as a deposit. If the kit is returned incomplete, a €20 fee will be charged.
8. For safety reasons, wearing gloves, protective gear, and a helmet is highly recommended.
9. Proper attire and decent behavior are required within the facility. Anyone failing to comply may be expelled without any refund.
10. Parents or accompanying adults are solely responsible for children and individuals under their supervision. Supervisors cannot substitute for parental supervision under any circumstances.
11. In the event of overcrowding, access time to the ice rink may be limited to 30 minutes. Evacuation of the skating area will be announced via loudspeakers and must be complied with immediately.
12. Animals are strictly prohibited within the facility.
13. Walking on the ice rink, or entering with scooters or any personal mobility devices, is strictly prohibited within the facility.
14. Group access to the ice rink must be arranged in advance and authorized by the Sports and Associations Department to benefit from the reduced group rate.

15. Visitors must follow the instructions issued by the municipal staff, particularly:

- Smoking and vaping are strictly prohibited inside the facility;
- Speed skating is forbidden;
- Skating against the designated direction (counter-clockwise) is prohibited;
- Forming chains of skaters is not allowed;
- Eating, drinking, smoking, or vaping on the ice is forbidden;
- Use of noisy devices is not allowed;
- Sharp objects (e.g. knives, box cutters) are not permitted inside the facility.

16. Engaging in dangerous games is strictly prohibited, such as:

- Throwing or passing objects of any kind;
- Throwing snowballs;
- Kicking balls or any other object;
- Playing chase games;
- Sitting on the guardrail surrounding the rink;
- Crossing the rink widthwise;
- Walking on the ice in shoes.

The rink is exclusively reserved for ice skating. All other activities are prohibited. Violators are subject to immediate expulsion from the facility.

17. No individual is authorized to offer skating lessons or classes within the facility.

18. Valuables or helmets may not be left in the lockers or at the ticket counter. The municipality accepts no responsibility for damage, loss, or theft within the facility.

19. Anyone who damages the facilities will be held personally responsible, in addition to being immediately expelled. The municipality reserves the right to initiate legal proceedings if deemed necessary.

20. In the event of inclement weather, evacuation of the rink is mandatory for safety reasons. No refunds will be given under these circumstances.

21. Any incident or accident must be reported to municipal staff on duty.

22. Facility staff are authorized to enforce these rules and regulations.

23. Failure to comply with these regulations or with the instructions of authorized staff will result in immediate expulsion from the facility.
